Message from the President

Since, 1991 CDS has been giving priorities for protection and fulfilled the requirements of children in need in the sector of education, health, protection and livelihood. There are several projects which has been running smoothly. This year (2021) CDS will try to create new initiatives with the motive to built a good relation and expansive recognition with policy makers, NGO/INGO, and concerned stake holders.



Capacity Building and Day care centre

CDS have been giving CB Training and running Day Care centre at Brick Kilns where in the month of December 2020, CRC members of Chandragiri Municipality and Ward 22, Bungamati, Lalitpur Metropolitan City held an awareness program on Child rights, their roles and responsibilities in regard to Child protection where a total 33 participants were present encompassing of 6 male and 27 females. This will allow CRC to support and protect the vulnerable children in their respective areas. Likewise training on Child Friendly Local Governance Program (CFYLG) was also conducted successfully for the staffs of CDs. Day care centres were runned at SS, Shree newa and Om Shree brick industries by providing children with nutritious food, followed by two hours sleep, playing and



learning in child friendly manner. While brick employers are building the day care centre at UK, Balkumari and Om Himalayan brick industry respectively. At Hira brick industry, a spacious area is managed to run the day care centre. While at Uma Maheshor, the implementation of project intervention is currently under construction. Whereas, the children in the day care are being supported with tracksuit, bag, shoes and stationery items. 1200 pieces

of blanket has also been purchased which will be distributed once the brick profiling is completed. In the sector of health, altogether 8 events of Occupational Safety and Health (OSH) conducted targeting brick employees, where they got information on basic safety measures of OSH. The orientation was facilitated by Resource person from Department of Labor and Employment.



INCEPTION MEETING WITH LOCAL GOVERNMENT OF CHANDRAGIRI MUNICIPALITY AND LALITPUR METROPOLITAN CITY

In the inception meeting held with the local government of chandragiri municipality and Lalitpur metropolitan city, CDS received approval letter for project implementation for FY 21 from ward 3, 14 and Chandragiri Municipality Office & ward 22, and Social Welfare Division, Lalitpur Metropolitan City. Similarly, a formal and informal meeting held with chairperson and brick employers at ward 22, Bungamati regarding operation of the day care centre.



CDS and WVIN played a role of facilitator between them. Chairperson and brick employers agreed to operate day care centre adopting safety measures to prevent against COVID 19. A informal meeting was also held with Federation of Nepal Brick Industry Association (FNBI). Draft indicators with regard to Child Labour Free Brick Industry was shared with President and undersecretary of FNBI. As per them, they have also developed a code of conduct for a brick industries which also incorporates with the draft indicators shared by us. The code of conduct implies to all brick industries within a nation.

SAKRIYA PROJECT

The project which focuses on Carpet industries received approval to implement SAKRIYA Project of 8 wards (1, 2, 4, 5, 6, 7, 8) of Gokarneshwor Municipality on 4-Dec. Representatives of Gokarneshwor Municipality (Mayor, Deputy Mayor, Chief Administration Officer, Women, Children and Social Welfare department) have assured to provide all the necessary support. All the ward representatives have also extended their support and coordination.

SAKRIYA Project has three outcomes:

Outcome 1: Identification and documentation of Child Labor.

Outcome 2: Awareness raising of Child Labor through campaigns.

Outcome 3: Case Management to address Child Labor.

To achieve outcome 1, 2 days orientation to Enumerators (CBOs and volunteers) on CBAR Assessment was held on 24–25 December. Enumerators was mobilized for data collection from 27 Dec – 4 Jan.

SPONSORSHIP PROGRAM

Capacity building training program was conducted for sponsorships staff, which included 2.0 (photography and videography) and Child Expression Worksheet (CEW) which will be filled in upcoming days by Registered Child (RC) in support of sponsorship field mobilizers. Inception meeting was held with

the local government of Balaju-16 and Kirtipur Municipality. Project objectives were highlighted and details of interventions were presented during the meeting. Approval letter received from both working sites in regard to project implementation. Likewise a registered child who had a spinal cord injury due to an accident happened to develop a backbone tumor, which was needed to be operated immediately so accordingly, CDS supported total sum of 40000 NRS.
