### ***BRiCKK and PCESP projects' Quarterly Meeting (October 2021 to December 2021)***

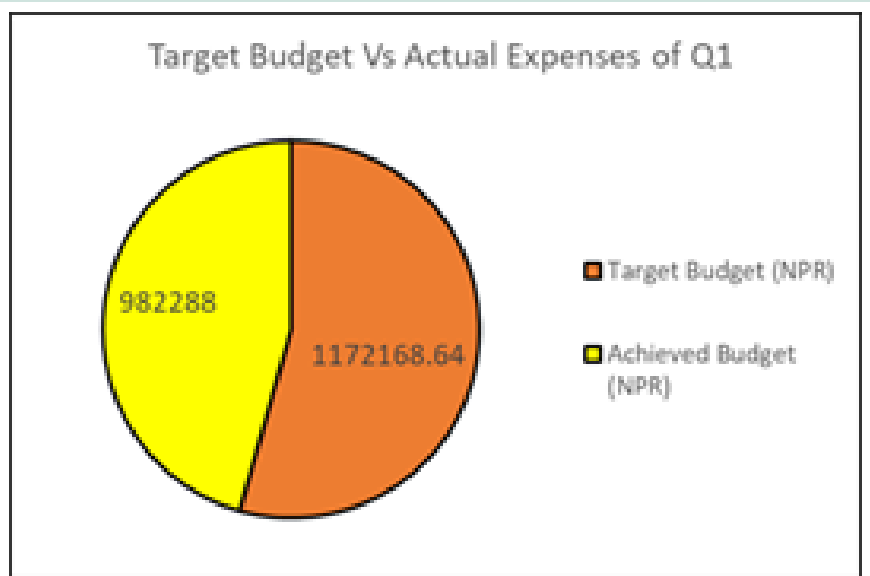


*Program Officer sharing the achievements of Q1 of PCESP and BRiCKK under WVIN*

In the presence of representatives from World Vision International (WVIN), Child Development Society (CDS), and Good Neighbours Nepal (GNN), a quarterly meeting was held at CDS Kapan headquarters on January 14, 2022. Both the organizations- CDS and GNN presented a presentation highlighting important accomplishments made during the first quarter of WVIN-supported initiatives (i.e. Oct 2021 to Dec 2021).

### **Under Building Resilience with Children in Kathmandu's Brick Kiln (BRiCKK\_Phase II)**

- The number of activities targeted for the first quarter (Q1) was 19, but 45 were completed by preplanning 34 activities from the second quarter (Q2) of the small amount budget. IT is because the activity were based on the needs of the brick employers, eight activities have been postponed from Q1 to Q2

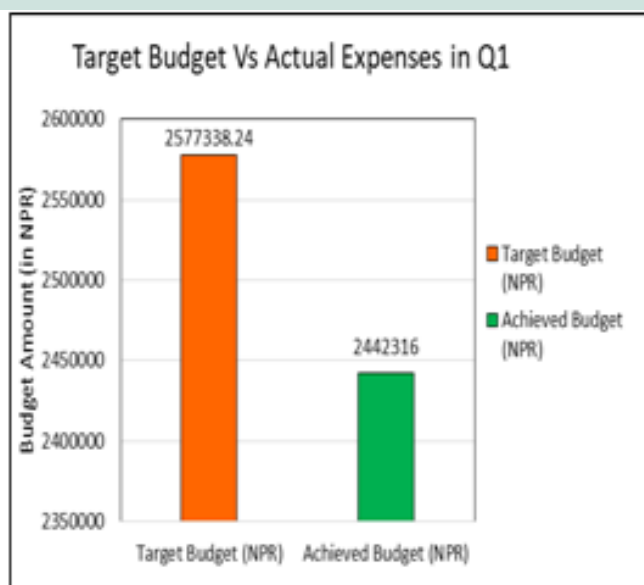

- From a programmatic standpoint, the activity objective was met 237 % of the time, and the budget target was met 84 % of the time.

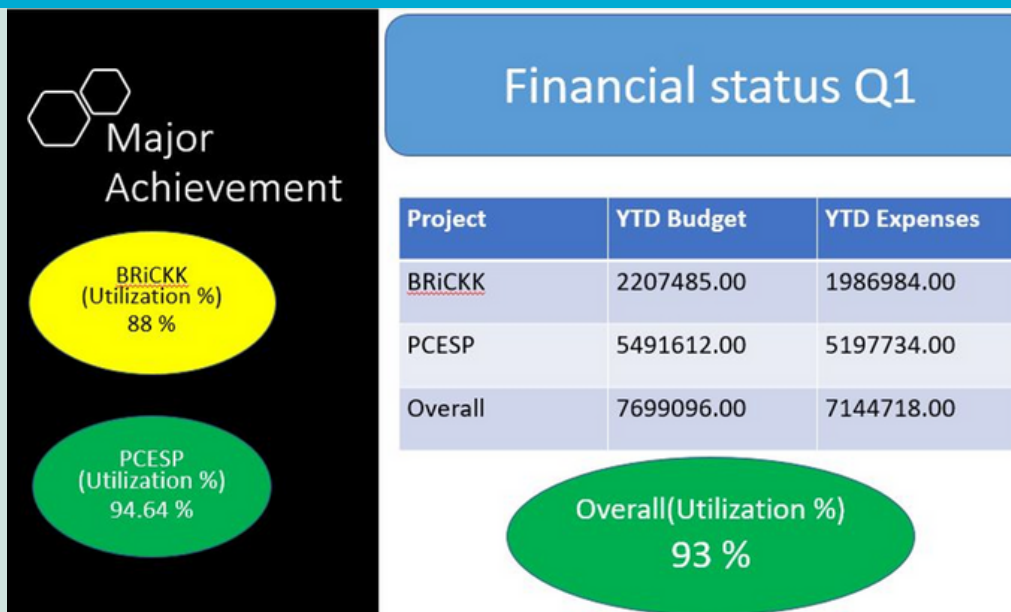

## ***Protection and Community Engagement & Sponsorship Program (PCESP)***

- The number of activities planned for the first quarter (Q1) was 76, however 56 were accomplished after deferring 20 activities to the second quarter (Q2).
- 39 activities were postponed from Q1 to Q2 since they were based on the needs of the community and local government. Likewise, the amount of budget targeted for Q1 was NPR 25,77,338.24, however, have achieved to expense NPR 24,42,316 by preponing of 20 activities.

- Overall, from programmatic point of view, the activity target achieved consist of 74% and achieved budget target is 95%.
- The overall number of beneficiaries reached in Q1 was 1633, with women accounting for 487, men for 323, girls for 455, and boys for 368. Dalit: 122, Janajati: 1000, Madhesi/Muslim: 36, Brahmin/Chhetri: 475 are the ethnic groups represented in the data.

# Training on Child Labour Monitoring

*Mr. Surendra Tamang, (CRC member) put his opinion as "we will conduct a series of awareness program in our ward to end child labour. During capacity building training on child labour and monitoring organized by Chandragiri Municipality in support of project implemented by CDS/WVIN."*

CDS hosted a two-day training for members of Chandragiri Municipality's Ward Level Child Rights Committee and Lalitpur Metropolitan City's Ward Number 22, Bungmati, in support of World Vision International (WVIN) and Chandragiri Municipality. The goal of the child labor monitoring training is to improve CRC members' ability to monitor the situation of child labour at their respective areas. In addition, this training has aided in the development of an action plan for appropriate monitoring and raising awareness about the issue of child labor. The Ministry of Labor, Employment, and Social Security has named as one of the municipalities to be designated as a Child Labor Free Municipality. There were a total of 21 participants. This trainig was facilitated by the officials of MoLESS and NCRC (Naitonal Child Rights Council).



## *Capacity Building for the Members of the Child Protection Committee*

A three-day training from January 18–20, 2022, on child protection capacity building was held in Kirtipur. There were 22 participants from the Child Protection Committee of the Kirtipur Municipality's Wards 1–10. The training's objectives are to improve participants' ability to respond to child protection issues in their communities by improving their skills, knowledge, and abilities. This training also helps to enhance participants' understanding of the roles and responsibilities of the Child Protection Committee. The program was jointly organized by Kirtipur Municipality and CDS in support of World Vision International.

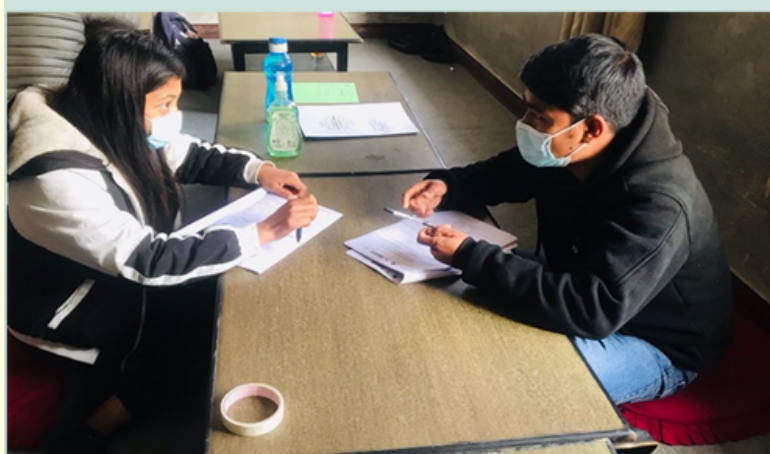

Intended for the representative of six CBOs of Surya Binayak Municipality and Bhaktapur. CDS has been conducting 3rd phase research on the presence of child labour in all the brickkilns and carpet industry of Surya Binayak municipality,

The objective of the training was to enhance their capacity to use kobo tool application and practically collecting the data on the status of child labour. The two days orientation program was held successfully and representatives of the CBOs were mobilized for the collection of data on child labor in all the brick industries and carpet factories in Suryabinayk Municipality

*We observed that majority of brickkilns have child labor with the evidence of child labors on 11 brick industries out of 12 while visiting to the brickkilns of Surya Binayak. The impression and findings of the visit can be concluded as the children living on those areas are vulnerable in terms of avoiding the child labor policy, Health, Hygiene & sanitation issues. They are deprived of their child rights access to free education.*
