CDS has been supporting children by making them aware of their rights through different activities like education, awareness program, and the establishment of child clubs, daycare center, mother and child health clinics. Since its establishment, it has been rigorously working with different national and international organizations to ensure the child rights of Nepalese children through preventive and curative approaches. CDS has been contributing to bringing change in the lives of children by adopting various strategies and working directly with children and women. Currently, CDS has its operational presence in 5 districts of Nepal Kathmandu, Lalitpur, Bhaktapur, Kavrepalanchowk, and Kailali and is working especially with children and women targeted for the improvement of lives of children by addressing the issues of child protection, survival, development, and participation with direct and indirect approaches.

ACHIEVEMENT OF 90'S

- Accomplished research on 100 carpet factories on the situation of carpet factories labourers.
- Organized health camps in Kathmandu and other parts of the country annually since 1991.
- Organized meetings among social workers and government officials in 1991 to collect suggestions and recommendations on Children's Act 2048.
- Withdrew 700 children from stone quarries.
- Initiated campaigns from 1993 to 1995 to create awareness among the mothers and teenage girls working in the carpet factories on issues such as health, STDs, HIV/AIDs
- Raised funds and established Siddhi Memorial Women and Children Hospital, Bhaktapur.
- Worked as part of Consortium, Good weave (Past named as Rugmark Foundation).
- Initiated action for the formation of Child NGO Federation in 1994.

- Conducted follow-up research on the Situation of child labour in Zari factories (embroidery) in 175 factories at Kathmandu Valley in 2014.
- Initiated, formed, and supported District-level School Network for improvement of quality education in public schools in 7 District of Nepal started from 2007 to 2012.
- Provided sponsorship, to 2901 children to date for their regular education.
- Constructed 18 Temporary Learning Centers (TLC) in 9 community schools of Bhaktapur District, 16 Temporary Learning Center in Ramechhap, 8 Child-Friendly Spaces and 3 Child Listening Posts in Kathmandu, 5 Child-Friendly Spaces and 5 Child Listening Posts in Ramechhap post devastating earthquakes in 2015
- Initiated advocacy events/campaigns/delegations in coordination with child right related networks to sensitize different levels of associated government particularly Ministries, Departments, and other related stakeholders for ensuring child rights by identifying policy gaps from 1991 to 2015.
- Declared 7 Brick Industries as child labour free in 2014 and 2015, together with District Child Welfare Board, Bhaktapur.
- Provided NRs. 24,73,000 as seed money in 2015 to 3570 marginalized and underprivileged women to be used as matching funds for micro business. With this seed money, a sum of NRS. 2,68,67,399 has been accrued to date. The transformation scene as such in women groups has helped promote individual business aimed at increasing their income which ultimately has been invested in the education and health of their children.

• 11 vulnerable children who had been separated from their families were reintegrated in 2015

FROM 2016 to 2017

- 276 children from Kathmandu, Bhaktapur, Kavre, Ramechhap, Gorkha, and Kanchanpur were supported through Formal School Sponsorship Program
- 704 women in 30 groups have benefitted from Self-Employment Education Program by conducting literacy and business education workshops and LGA and livelihood support.
- 74 children from the coaching class and 64 children from 3 NFE centers have benefitted in Bhaktapur and Lalitpur from Brick Industries.
- 1000 children received educational materials (school uniforms, bags, copies, and stationery items) in presence of their parents and school representatives.
- 45 different schools of Bhaktapur, Lalitpur, and Ramechhap were provided with school maintenance support as per their need.
- Health orientation, counseling, pathology services, and first aid have been provided to 1479 patients, 522 were male and 957 were female, and 274 patients received pathology services.
- 778 mothers and their children of brick factories, students, and Daycare children have been benefited from general health and dental camp- In coordination with CDO office Bhaktapur, 10 intergenerational dialogues have been conducted and a letter of attention has also been submitted on the issue of child labour.
- Two Community blocks were renovated in Ramhiti and Mandikatar, with 1700 inhabitants in Ramhiti & 780 inhabitants in Mandikatar were benefited.

- A total of 272 male-female) children who were at high risk were provided with Rs. 4,000 cash support per head in collabouration with DCWB.
- 20 adolescents received vocational training.
- Thirteen unaccompanied children who were in Brick industries were rescued and reintegrated into their families in collabouration with DCWB.
- 93 children were taken into case management and were provided services when needed
- On the occasion of World day against child labour, a 12 points memorandum was handed over to Prime Minister K. P.
 Sharma Oli.
- 47 children were reintegrated into their original place at Dang, Sindhuli, Rolpa, Salyan, Puthyan, and Rukum in 2017
- 124 Brick Industries working women of 5 SEEP groups were registered in District Livestock Office and District Agriculture Development Office. These women committed not to send their 205 children to work in Brick Kilns and vowed to continue their education.
- Under the theme of Health, various projects of CDS contributed to reaching a total of 7935 individuals (5129 F, 2806 M).
- A total of 1917 children (1238 F, 679 M) directly received educational support
- 262 individuals (183 F, 79 M) received family support/IGA.
- 11,549 children/adolescents were trained and made aware of various protection issues.
- 14,409 individuals were advocated on child rights and protection issues at local, district, and national levels via different means.
- CDS provided different services to 35,277 beneficiaries in the year 2017.

FROM 2018 to 2019

- Implementation Plan of National Master Plan on Child Labour Elimination at the municipal level (Chandragiri Municipality) was made.
- 275 Brick workers have been aware of Occupational Safety and Health (OSH) regarding OSH directives and have formed 6 Safety & Health Committee in Brick industries.
- Nationwide survey on Carpet and Garment industries has been completed in the lead of MoLESS and technical support of Central Bureau Statistics (CBS)
- 15 Ward Level Child Rights Committee (CRC) have been formed and capacity building training has been conducted in Chandragiri Municipality
- Four series of videos with the child labour issues entitled; Construction Child Labour, Brick Industry Child Labour, Child Labour in Domestic and Child Labour in Transportation Sector has been developed and broadcasted via NTV & Kantipur TV for raising awareness in the nation.
- Program visit and monitoring by MoLESS, Labour & Employment Office, Deputy Mayor, Chief Administrative Officer & government officials.
- Different initiatives were taken to ensure OSH & child labour free standards with the representatives from MoLESS, DOLOS, OSHC, I/NGOs, Chandragiri Municipality
- 1060 Brick workers have been aware of government social protection schemes and 19 people made citizenship cards as well.
- 414 children (from Brick industries) 227 Children (underprivilege) received formal education support in different schools

- NPR 5 lakhs has been handed over for the Emergency Child Fund at Chandragiri Municipality after having endorsed the 'Child Fund Guideline 2076'.
- Awareness activities were conducted with regards to child labour and child protection by means of the rally, inter quiz contest and drawing competition, messaging, PSA/radio program, an online portal on the occasion of world day against child labour 2019.
- 90 adolescents were orientated/counselled on Business Facilitation Curriculum (individual business carrier plan, leadership, market management, networking, and business start-up support)
- 55 Brick workers completed 3 months-390 hours CTEVT technical training course. Among 55 trainees, 28 are engaged in tailoring, 2 are working as masons, 14 of them are working as electricians and 11 of them are working in repairing motorcycles and among them, 45 have given CTEVT skill test where 31 passed in CTEVT exam.
- 6,78,727 bulk SMS has been disseminated in wider range on the occasion of World Day Against Child Labour-2019 "बाल श्रम विरुद्धको अभियानमा बाल श्रम प्रयोग नगर्ने नगराउने संकल्प गरौं" in coordination with Department of Labour and Occupational Safety and Health.
- 199 families have done in formal saving after orientation on Saving Credit Mobilization in Brick Industries.
- 512 family members of 150 Households at Sindhuli district got access to health insurance from the Government of Nepal where 70% of them received free health check-up services.
- Hoarding board, cautionary signboard, and the poster were installed in public places at Chandragiri Municipality regarding Child Labour Elimination, OSH/WASH and 12 toilets, 12 bathroom, and 6 rings well with 6 water tanks were established in the Brick Industries.

- Kathmandu Brick Employer Association has signed the commitment to end child labour in the Brick Industry
- 192 students got more learning in coaching centers in Brick Industries.
- 226 children (Brick workers children) 76 children (in Kapan daycare) aged 2-6 yrs were protected via Daycare Center facility with nutritious food and track-suit.
- 142 adolescents received training on life skills, income & expenditure, saving habits, reproductive health, alternative livelihood, and enterprises and they have been indicating positive behaviour changes

From 2020 to 2021

- A research report entitled: Report on Changing State and Prevalence of Child Labour in Carpet and Garment Industries in Nepal was officially disseminated in presence of MoLESS, CBS and Labour and Employment Office. 2000 pieces of report was distributed to different like-minded organization working in the field of child protection.
- 860 children of brick workers supported with education materials for their schooling purpose. As per Endline Evaluation Survey of BRICKK project, there is a rise in children's enrollment in schools from 44.9 to 80.7 percent compared to baseline data.
- 592 children aged 2 to 6 yrs directly benefitted from day care centre at brick industries
- There is positive changes in parents such as receiving of children from day care centre timely, maintaining hygiene of their children after providing positive parenting orientation to 968 brick workers.
- 305 brick workers were linked to formal saving institutes in the name of their children after facilitating and counselling

- to 931 briock workers on income & expenditure management, saving habits and financial literacy.
- 2058 children and families directly benefitted from health camp organized at brick industries
- MoLESS enlisted Chandragiri Municipality and allocated Rs 3 lakh budget for Child Labour Free Municipality Declaration related interventions. The municipality itself have allocated Rs 5 lakh for same provision.
- The CRC played a vital role to unite 22 children to their families back in their villages by removing them working as labours in the industry.
- 41 brick families were supported for income generating activities for their additional livelihood during season off to prosper their lives so that their children can get good life and better future ahead.
- BRICKK project facilitated to provide technical training to 60 youths in four different trades i.e. Tailoring-37, Building Electrician-8, Motorcycle repairing-13 and excavator-2 affiliated to Course of Technical Education and Vocational Training (CTEVT). The workers were provided with entrepreneurship training along with basic tools and equipments to startup their planned business to become self-reliant.
- Under PCESP, through community and stakeholders initiation, CDS/WVIN by means of project was able to provide critical health support to 11 RC
- 122 children were provided psychological counselling during the COVID 19. 352 HHs constituting of 1082 families supported with food ration support to meet their immediate nutritional requirements during the pandemic of second wave of COVID 19. Likewise, 18 disabled family supported with food ration and stationery materials during the second wave of pandemic of COVID 19.

- The project also supported 175 children in four-child care home in Chandragiri Municipality with food packages to meet their nutritional requirement. And 288 self-learning materials (Grade 1 to 5) for brick workers' children were supported focussing on the education of children during COVID 19 pandemic.
- Under PCESP project, total 4392 sets of hygiene kits and 2298 sets of Self Learning Materials supported to registered children during pandemic of COVID 19. Similarly, 611 MVC/F supported with food and stationery materials as per their need assessment.
- 300 most vulnerable families supported with food ration during pandemic of COVID 19 under COVER II
- CDS was able to collect 247 data on case management from Gokarneshwor municipality. Based on the prioritization of emergency support, care plan of 12 children was prepared and submitted to TDH.
- CDS successfully coordinated with Gokarneshwor Municipality and collected 460 data of children working in the carpet industry of Gokarneshwor municipality. CDS also collected 32 data of the children's guardians working in the carpet industry and 90 owners of the carpet industry
- Food items and stationery materials were distributed to 14 children working in the carpet industry of Suryabinayak.
 Food items were distributed to 311 children working in the carpet industry of Gokarneshwor Municipality under the case management system.
- Emergency support was provided to 11 children working in the carpet industry of Gokarneshwor Municipality under the case management through the TDH,
- CDS has able to develop the five years child labour elimination strategy.

THEMATIC WISE MAJOR COMPLETED ACTIVITIES IN 2021

1. EDUCATION THEME

To intervene with appropriate programs, enable children's access to the basic quality of education in a child-friendly environment.

a) Formal School Sponsorship Program (FSSP)

Project Goal: Provide educational opportunities to children who are at higher risk of probable child labor, vulnerable, from poor economic background and marginalized group of the society.

Since its establishment, CDS has been implementing various programs for children prioritizing their educational rights. The FSSP began in 1997 with the aim of providing formal educational

opportunities to children who are from poor economic background, at higher risk of probable child labour, vulnerable, and marginalized groups of the society.

The main objective of the program is to support underprivileged children (who are likely to be deprived of schooling) and bring them to the mainstream of formal education. The program also encourages parents to send their children to schools to continue their studies thereby lessening their economic burden and gradually making parents responsible.

Different national and international partners and individuals (CDS advisory committee, board members, life members, staff, well-wishers, financial institutions, and social workers) have been supporting the children to come into the limelight of formal education, ensuring their rights to education.

This culture is initiated by founder CDS Board Executive itself as each board member contributes to supporting one or more than one child in mainstreaming them with formal education. It comprises of collecting the fund with the aim 'no one child to be deprived of basic education. For the long term, CDS has planned to open the 'Akhsya Kosh' bank account and the fund

has been collected from CDS executive board, life members, and well-wishers.

Key Achievement of this Program

- √ 123 underprivileged children have been getting formal education for the year 2078.
- ✓ Sponsored children received stationeries including school dress from the organization this year.
- ✓ The organization has been regularly monitoring schools and collecting fund from an individual donor for sponsorship support.
- ✓ Submitted the final/quarterly progress report to sponsors for the year 2021.
- √ 147 children have already passed SLC/ SEE Examination securing the highest position/marks from this program to date.



2. HEALTH AND NUTRITION THEME

To implement activities for the promotion of mother and child health.

a) Mother and Child Health Program

Project Goal: Provide services on clinical service, health orientation & training, health camp, counseling and pathology lab services to the marginalized children & community people.

Health care services in Nepal are provided by both public and private sectors even though it fails to meet international standards. Prevalence of a disease is significantly higher in Nepal than in other South Asian countries, especially in rural areas. Approximately 70% of health expenditure comes from out-of-pocket contributions which poor people cannot afford it. Thereafter, poor people are forced to live with illness.

Health services provided by CDS are mainly focused on underprivileged children and mothers from a marginalized community. School students, Daycare parents, and SEEP group women are benefited from various health orientation classes. Such economically poor families are provided with quality health services in health camps, health screening and clinical services, free medicine distribution, pathology services, and family planning services and counselling.

Activities and programs as such have been proven to be beneficial for many needy mothers and children. Such programs/services are being updated every year to meet the minimum requirements. CDS' theme contributes to SDG 3 "Good Health & Wellbeing" and SDG 6 "Clean Water & Sanitation".

Key Achievement of this Program

- Glenn Family Foundation Helps along with Child Development Society organized a Basic First Aid training conducted by Nepal Red Cross Society from 27- 30 November. The 4 days session was based on practical learning. The main objective of the training was to train the participants to be able to obtain theoretical knowledge and perform First Aid in a consistent and systematic manner. The trainees were more confident in providing basic life support and first aid during an emergency situation.
- 2046 persons have received services from mother and child clinic.
- Vulnerable children and women received prevention and prompt quality treatment for various diseases.
- With the help of health orientations, awareness was successfully raised among students and parents regarding health, nutrition and sanitation.
- Women of reproductive age were provided with counselling and free family planning services to promote small family and sustainable quality life.
- Sterile dressing services helped in control and prevention of wound infection.

- Patients are getting emergency and proper first aid services regularly.
- Regular nutritional assessment and monitoring of daycare children helped to keep a track of their nutritional status and ways to improve it.

b) Child Daycare Program

Project Goal: Facilitate a child-friendly and safe environment for children under 4 for their holistic rights and development of child.

Child Development Society (CDS) has taken admirable steps to improve the lives of underprivileged and marginalized children. CDS has been managing the daycare center since 1991 with the objective of creating a safe and healthy childhood. The concept of establishing a daycare center was raised with a situation analysis (focused on the economic aspect)



of women working as a daily waged labourer in different non-formal sectors. When parents work as a daily waged labourer, their children do not get proper care and a safe environment as they are taken by their parents to their workplace and left unattended. On one hand, children do not get a safe environment to grow, and on the other hand, parents cannot work effectively and earn more for their living. Besides this, the older siblings are engaged to take care of the younger ones at their homes and do not have the opportunity to attend formal school. So, it was thought to provide a daycare facility to children of parents working as a daily waged labourer, which would finally contribute to the proper growth of children and also contribute to the economic development of the family, as the older children would get the opportunity to go to school well. In addition, the children



living in the slums and as squatters are exposed to behavioural, cognitive, and social issues.

Specific Objectives

- To provide nutritious day meals to prevent the risk of malnutrition among the children by supporting health and sanitation
- To prevent the risk of increasing child labour
- To develop school-going practice in children
- To make parents responsible and aware about better lives of their children

Expected Outcome:

- Forty children (24b & 16g) belongs to poor and marginalized families benefited from the daycare program.
- The needy children would be able to grow in a safe environment in the center
- The productivity and income of parents working in different sectors would be increased
- Socialization and mental ability of the children would be developed
- The children will be able to learn and practice safe sanitation habits

 Nutrition status of malnourished children will be improved

Introduction of the center:

The daycare program is a core part of the organization, which runs six days a week in CDS office in Kapan, Kathmandu. The center operates with a focus on the physical and mental development of vulnerable children. Children participate in various activities, while the center is monitored and supervised to avoid any accidents or injuries.

Due to the COVID-19 pandemic, the program was suspended for a time, but we reopened on the 1st of November 2021 with 40 children in the center, including 24 boys and 16 girls. Regular activities conducted at the daycare center were divided into indoor and outdoor activities. They are all from low-income households.

Parents depend on daily wages as their source of income.

Daycare Center Activities:

Children attend the daycare center 6 days a week. Children learn to greet their elders when they enter the room, speak full sentences, and interact with their peers in a relaxed environment. Parents are encouraged to maintain the cleanliness and personal hygiene of their children as well as to create a child-friendly environment at home. At present, around 33 out of 40 children are attending the daycare center.

- Allows children to use their creativity and develop their imagination, dexterity, and other strengths
- Free Play and Creative Activities:
- Encourages in interacting with the world around them.





- Helps children adjust to the school environment and enhance their learning readiness, learning behaviour, and problem-solving skills.
- Creative activities like colouring, drawing, singing, and dancing.
- Encourage to carry out different activities.
- Support for

Day Meal Management:

Children are enjoying daily meals with different menus including the nutritious food required for their proper growth and development. With milk/meat, seasonal fruits and vegetables, and grains, four varieties of food are managed in a day. Children are encouraged to develop self-feeding habits, and if they are not able, then our support staff makes sure that they get their complete meal.

Food for Life Nepal, Budhanilkantha, Kathmandu supported food/rations material to CDS daycare center. 40 marginalized children are benefited with nutritious food. Rice 3325 kg, Salt 32 kg, Pulse (Daal) 300 kg, Oil 190 ltr., Soya Chunks (Nutrela) 280 kg, are handed over to CDS. The food consumption support



is managing for the daycare children for their midday meal program.

Height & Weight Measurement:

Height and weight were measured at the time of admission and every 3 months to compare their body mass index. Health progress is being observed and support is provided to children who are malnourished for their age and gender. From this, we can monitor the proper growth and development according to their developmental milestones. Parents are also obtaining benefits from the mother-child clinic of CDS.



3. CHILD PROTECTION THEME

To protect children from all forms of abuse, violence, exploitation, and neglect.

a) Building Resilience with Children in Kathmandu's Brick Kiln (BRiCKK)

Project Goal: Protected children from exploitative hazardous labour and their families have decent and viable livelihoods

BRICKK is a three years (i.e. from 1 Oct. 2018 till 30 September 2021) long project working with children and families in Kathmandu and Lalitpur districts. The project worked in 12 brick industries

and has reached 19,118 individuals that includes 5,776 children (Girls: 2,917 & Boys: 2,859) and 13,342 adults (Women: 6,657 & Men: 6,685) in these years.

The project focused on strengthening the government's regulatory mechanism on child labour elimination and ensuring child rights, creating a safer and non-exploitative working and living environment for families and children in the industries.

The project collaborated with the municipal government and brick industry owners at the local level and supported them in designing policies, action plans, operational guidelines for child labour elimination in brick and other sectors in the municipal area. Employers from the Federation of Nepalese Chambers of Commerce and Industry (FNCCI) committed to supporting the child labour free declaration process of Chandragiri Municipality in presence of Mayor, Deputy Mayor, Under Secretary of MoLESS, and vice president of FNCCI.

Chandragiri Municipality initiated the campaign against Child Labour with a slogan "Stop Child Labour" which has been imprinted in their stamp and used for official work for mass awareness. Additionally, the project designed awareness materials & hoarding boards

reflecting Child Labour Free notice/picture. Nationwide awareness was broadcasted on child labour elimination by initiating dialogue between local government and stakeholders on child labour free industry, promotion, sustainability of the industry, effective role of the local level, and efforts/ commitment made by the Federation of Nepalese Brick Industries to end child labour, via National TV. A Local Level Coordination Committee is functioning actively which was formulated for Child Labour Free Municipality Declaration. This year, MoLESS enlisted Chandragiri Municipality and allocated a US\$ 2489.83 budget for Child Labour Free Municipality Declaration-related interventions. Also. the municipality itself have allocated US\$ 5809.60 for the same provision.

Seventeen Child Rights Committees (CRC) (i.e 16 at Chandragiri Municipality & 1 at ward 22, Lalitpur Metropolitan City) are actively functioning to ensure child rights through awareness raising programs,

advocacy, and supporting the vulnerable children. This year, the CRC played a vital role in uniting 22 children back to their families in their villages by rescuing them from working as labourers in the industry. The CRCs jointly monitored with the local government in ensuring minimum standards of occupational safety, safe spaces for children, provision of clean and safe drinking water, and education for children. In total, the committee supported medical treatment to 10 children from the Brick Industries with adverse medical condition through a child fund established in Chandragiri Municipality. The municipal government had allocated US\$ 1664.58 in each ward as child fund (FY 20) & US\$ 1907.76 (FY 21) respectively which can be utilized for supporting vulnerable children in case of critical health situation

on recommendation of CRC. The CRC came forth and distributed hygiene kits followed by raising awareness on COVID 19 focussing on the preventive measures from it. This year, virtual program was organized by CRCs of Chandragiri Municipality on the occasion of World Day against Child Labour and highlighted the work done by CRCs. On National Children's Day (14 Sep 2021), Chandragiri Municipality organized an interaction program between the local government and the children that created a platform where children were able to put forth their voice. The project also supported the families and children in accessing the social protection services available in their municipalities. In this regard, the Social Development Department of the Municipality provided an orientation on available social protection





services like vital registration, scholarship for education, disability allowance, insurance, food allowance, etc. Similarly, in the Sindhuli district from where most families come to work in the industry, the municipality was supported in the vital registration program which included birth registration of children in the municipal system.

The key strength is the project's integrated approach to protect the children's health, safety, and education, implementation of OSH guidelines for improving working and living conditions inside kilns, protecting their health and promoting alternative livelihood options and saving habits for their economic resilience, also well serves the objectives of the project. Daycare center supported by the project for children below 6 years ensures access to their basic rights to education, nutrition, health,



and hygiene. Most of the parents were not even aware of vitamin, polio drops, and other immunization vaccinations provided to the children before project intervention. Not only the daycare center but increasing access to education for children going to school with various educational support are found to be relevant to the needs of families living in kilns and contribute to the national priorities as well. Rationale for implementing OSH guidelines to improve and protect the health and safety of workers and children working and living in the kilns is also found to be appropriate. The local government is the major stakeholder for monitoring kilns and implementation of OSH and childlabour-free guidelines. The project effort in raising awareness and coordination for formulation and implementation of guidelines on eliminating child labour from the formal and informal sectors.

b) Protection and Community Engagement & Sponsorship Programme (PCESP)

Project Goal: Children are loved, protected, and empowered

For genuine care, protection, and empowerment of children, urban PCESP has been working in close coordination, coherence, collabouration,

and harmonization with formal actors i.e. Ward and Municipal level Child Protection Committees (W/MCPC). Additionally, the project is working in close cooperation with Community-Based Organizations (CBOs) and is playing a vital role in identifying child protection-related issues, the importance of sponsorship approach, and child monitoring. Through CBOs' proactive and action-oriented steps, critical and child protection-related cases are referred and reported to W/MCPC who in turn take necessary actions to ensure the well-being of the child. Thus, both CBOs and W/MCPC, have been functioning effectively pertinent to child protection.

Through 19 orientation events, 626 RCs/Non-RCs and stakeholders have been oriented on sponsorship approaches which in turn have supported communities to know about the basics of the sponsorship operations. Six thousand five hundred copies constituting of massageable sponsorship calendar received by RCs, Non-Rcs, and local institutions.

"One of the local officials from Kirtipur Municipality said that the Sponsorship Calendar helped him to know the detailed information about the Sponsorship project, where he said "Previously I thought it was some kind of scholarship program, but I was wrong about it."

RC by means of projects is continuously in touch with sponsors via letters. Total sponsored children consist of 4,040. In one part, this has created a heart-to-heart connection between sponsors and children while in the other part, children got an opportunity to sharpen their skills in writing, expressing their feelings in an innovative and creative way. The RCs are motivated to share their culture and community environment using drawing and artistic work. Additionally, the children's life has changed positively after their continuous sharing with the sponsors. One of the RC (ID-4,474) expresses

"I am very happy to share my thoughts with my friend through letters. Also, the positive suggestions given by my friends have motivated me to do my homework regularly and I have developed the habit of listening to my parents in a disciplined manner".



RC with ID 3,609 shares

"I would like to thank World Vision International Nepal (WVIN) & Child Development Society (CDS) for providing food and sanitation assistance in emergencies like COVID 19. This experience of caring like a parent has motivated me to be more proactive in my regular work of reading and writing".

One of the RC said that

"Friend from Hongkong has never seen us, however, they think positively about me. I feel lucky I believe that my future is bright due to this program. From the program, I have learned to call 1,098 in case help is needed for children. For all these, I like to thank CDS and WVIN".

Regular monitoring of RC supported RC to be cared for and protected. RC ID 3,957 expresses her happiness by saying

"I am very happy to be asked about health, education, and family through regular monitoring. I have experienced caring as a member of my family and I hope to continue to have a sense of intimacy in the days to come"

Two hundred ninety-two CBOs, community members, and stakeholders (women's group network, WCPC, ward level child club networks, ward members, teachers, health professionals, etc.) oriented on Child Monitoring Standards (13 events) for effective monitoring of children encompassing RCs. This event has been very fruitful in respect to the communityled monitoring and care, participation, and protection. Moreover, this is one of the best examples of implementing project intervention in an integrated approach as the community people are being aware of sponsorship, child protection, and its mechanism disseminating basic information about GO Bag. Two children



who dropped out of school were admitted to continue school in the lead of community who had constantly monitored the children at ward 4, Kirtipur Municipality. They have also shared the information with the respective ward Child Protection Committee. One of the members of the community expresses

"Because of the poor economic condition and COVID pandemic situation, two children had dropped the school, but with constant monitoring and facilitation provided by CDS & WVIN staff, we were able to help them timely & I am glad for that. We commit to monitor further and do necessary activity for ensuring the child's well-being".

Ward 6 WCRC played a vital role in reuniting the child (ID 1561) with their parents who had eloped for marriage at the age of 15. The mother of a child says

"We are thankful towards Bara police station, helpline and CDS/WVIN team for supporting us to bring her back".

Similarly, the mother of RC 0940 shared that

"I am very grateful to WCPC and CDS because of whom I could get the medical support for my child on time. Now, she is much better".



Through community and stakeholders initiation, CDS/WVIN using the project was able to provide critical health support to 11 RC this year. Similarly, 398 new children registered in the sponsorship project in coordination with the local government, community and stakeholders. Two events of Sponsorship in Programming (SIP) followed by 1 event of Project Quality Self Review Tools (PQRST) reflected the good impact of project interventions.

Fifty-five RC were bid farewell in presence of the local government who expressed that they were glad to be a part of the sponsorship project and committed to support in their community in the upcoming days. Despite the frightening situation of the COVID 19 pandemic, RC was supported with total 4,392 sets of hygiene kits and 2298 sets of self-learning materials followed by 300 food packages which comprise 75% of RC. Keshav Kari, the father of RC with ID 2622, said:



"My child is very happy to get selflearning materials. Usually he doesn't study, but after receiving this book I have seen most of the time he has been reading this book. Thanks for your support".

RC with ID 1,123 expressed:

"I like to thank World Vision. In this COVID 19 pandemic situation, World Vision provided me with self-learning materials. It is very useful to us, from this book, I learned to write my daily routine and follow them. I learned to wash my hand with soap by following the steps of handwashing. This in turn, helps me to be safer from COVID 19."

11 RCs have been supported for critical health this year. The project supported needy children with food ration, medical support, self-learning materials, and hygiene kits. The health status of the RC

along with their families was regularly monitored by project staff and provided necessary support as per their need during the lockdown period of the second wave of the COVID 19. Additionally, 122 children were provided psychological counselling, 18 disabled family supported with food ration and stationery materials during the second wave of COVID 19 pandemic. Similarly, the CDS team advocated for the management of a movable ramp for the recently established Child Friendly Contact Room at ward 7, Kirtipur Municipality, Albeit there was a second wave of COVID 19 this. year, children participated in the life skill/ rupantaran classes through online in the facilitation of CDS and WVIN. RCs grasped the opportunity to participate in World Vision Hongkong Cross Country sharing on Climate change. RCs & other children showed their meaningful participation on June 12 organized by the Municipal Level Child Club Network of Kiritpur Municipality on the occasion of World Day Against Child Labour. They organized an open talent show and interaction program virtually among the child club members. Child representatives had the opportunity to put forth their queries regarding the use of the budget allocated for the welfare of a child at the ward level. One of the members of the child club asked that:

"How to ensure that the budget allocated for a child at ward level is being used properly for the sake of the welfare of the child? If the budget allocated for the FY is not utilized then what will happen?"

In total, 56 cases have been identified to date. Through ward level Child Protection Committee, 11 RC have been supported for critical health. Besides that one child has been reunited with the family who had eloped for marriage at the age of 15. Similarly, one child has been rescued who was being abused by her father. The counselling service has been provided to the rescued child.

During the implementation of project interventions, CDS staff ensures the participation of 33% of female. Further, the project assures equal inclusion of girls and boys during the registration of children. Two thousand six hundred thirty-five boys and 2,279 girls are registered as RCs. Municipal level Child Rights Committee and Municipal level Child Club Network of Kirtipur Municipality is functioning in a good spirit for the well-being of children.

Community people have been sensitized to community led monitoring and care of children, which has built a loving and caring environment. Also, community people along with other stakeholders have been oriented on the sponsorship approach and its working modality. They know that RC are just representing the community and change in RC will be the reflection in the community. Thus, community lead monitoring and care has played a prominent role in building a peaceful environment.

Community-based child protection mechanisms are playing a vital role in referring the critical health issues and child protection issues to ward-level child rights and child protection committee. Therefore, there is an engagement and dedication of CBOs, local government and stakeholders in the child protection sector. Municipal and ward level Child Protection Committee and Child Club Networks are working together for child protection. Further more, informal actors such as women's group network, teachers, health professionals are also equally contributing for the protection of the child. WVIN partnered with CDS have advocated for strengthening policy related to child protection issues followed by constant support for the declaration of Child Friendly Local Governance.

Through sponsorship and project interventions, trust and social cohesion

has been built to some extent. Communities either formal or informal actors are engaged in child protection-related issues, which in turn, results in love and care of a child. After receiving life skill/rupantaran and protective skills, children are confident, could express their thoughts and opinions clearly, and are able to tackle a difficult situation. One of the peer educators expressed that

"Life Skill TOT has changed my life completely and I took a shine to this change within me. Rupantaran helped me to groom my inner personality and help to build up my confidence level as well as public speaking skill. Additionally, training provided by "girls kick" under WVIN and CDS monitoring has garnished my fortitude and I'm proud to say that it's 'not only me but every participant and every peer educator have felt that change within themselves"



Playing Materials Support for Children's Park

This year, the project supported playing materials for Children's Park as a micro project at ward 4 and ward 7 of Kirtipur Municipality. Using the project, the total budget supported is NPR 12,44,474. Ward no. 7 is on the verge of declaring this ward as the Child Friendly Local Governance (CFLG) and having a children's park is one of the indicators of CFLG. The local government of ward 7 seek support for the playing materials. Ward 7 itself has allocated a budget amount of NPR 20 lakhs for the construction of the children's park. Further, they have been documenting as per the indicator of CFLG in support and facilitation of CDS and WVIN.

Inward 4, the active youth realized the need for the children park and the local government support for building the park in support of CDS and WVIN. As per the consensus of 2074, the total beneficiaries reached through the micro project is 1700HHs, including 341 RC at ward 4 and 149 RC at ward 7 respectively. Most of the children were stuck in the four walls of their homes as the schools were closed for a longer duration because of the second wave of the COVID 19 pandemic and the prohibitory order implied by the

government of Nepal. The children's park at ward 4 and ward 7 have been a boon to the children for recreational purposes as they can enjoy playing and running, which in turn supported their physical, social and mental well-being. The communities and local government agreed to install necessary signboards and hoarding boards reflecting the child protection and clean environment.





c) Sakriya Project

Project Goal: Build the capacity of civil society to more effectively detect and combat forced child labor and other labor abuses in Nepal's brick, embroidery and carpet weaving sectors.

The Sakriya project is a research-based community project with the Nepali term with meaning "Active". It builds the capacity of Nepalese civil society to more effectively detect and combat forced child labour and other labour abuses in Nepal's brick, embroidery (zari), and carpet weaving sectors. The project supports a core group of civil society actors to leverage partnerships across Nepal's child protection networks to facilitate access to services for survivors of labour abuses and reduce the risk that adults and children will be forced into harmful work in these sectors. The project is also working to improve the capacity of these networks to raise awareness of these problems, and improve capacity to implement initiatives to address child labour and/or forced labour and violations of acceptable conditions of work. This project is implementing in Survabinayak Municipality & Changunarayan Municipality Bhaktapur and Gokarneswor Municipality Kathmandu targeting to children who are in Brick, Carpet and Zari industries.



Objective of the project:

- Enabling the network of NGOs and CBOs to end labour exploitation.
- To create guidelines for local people's representatives, employees to increase capacity for child protection, child labour, and end child exploitation.
- Increase the capacity of the concerned rural municipality, municipality, government staff, local representative body, and stakeholders for the end of child labour and labour exploitation using the prepared document.

Key Achievement of the project

- CDS successfully coordinated with Gokarneshwor Municipality and collected 460 data of children working in the carpet industry of Gokarneshwor municipality. CDS also collected 32 data of the children's guardians working in the carpet industry and 90 owners of the carpet industry
- CDS was able to collect 247 data on case management from Gokarneshwor municipality. Based on the prioritization of emergency support, care plan, 12 children are supported.



- Food items and stationery materials were distributed to 14 children working in the carpet industry of Suryabinayak.
- The stakeholder (CBOs, LCRC, and WCRC members understand Social and Behavioral Change Communication (SBCC).
- Emergency support was provided to 11 children working in the carpet industry of Gokarneshwor Municipality.
- Food items were distributed to 311 children working in the carpet industry of Gokarneshwor Municipality under the case management system.

- Project staff received ToT on the Case Management and basic helping skills facilitated by (TDH) Terre Des Homes
- Capacity assessment workshop has helped to identify the organization's capacity to eliminate child labour issues.
- Organization has been able to make various policies of case management system to manage different case management activities
- CDS has able to develop the five years child labour elimination strategy.



4. LIVELIHOOD THEME

To support the livelihood activities of adolescents and families working in a brick kiln

To empower rural women via. education and income-generating activities

a) Building Resilience in Children of Brick Kiln of Kathmandu (BRICKK)

Project Goal: Protected children from exploitative hazardous labour and their families have decent and viable livelihoods

BRICKK project was implemented at ward 3, 9, 12 and 14 of Chandragiri Municipality at 6 Brick Industries viz; Aadinarayan Brick industry, Balkumari Brick industry, Chundevi Brick Industry, Om Himalyan


Brick Industry, Jaya Matribbhumi Brick Industry and Jyoti Itta Tayal Brick industry, respectively. Overall goal of the project is to support children and families in brick industry and protect them from exploitative hazardous labour and their families to have decent and viable livelihoods.

With the spread of COVID-19, the project supported both the municipal government with health equipment support such as oxygen cylinder, oximeter, thermal gun and PPE sets.

The Economic Resilience outcome of the project emphasizes youth and families with additional livelihood options to increase their economic security through stable business. This year 60 youths



were enrolled to four different trades of technical training: Tailoring (37), Building Electrician (8), Motorcycle Repairing (13) and JCB (2). Within three years, a total of 115 workers were provided with technical training affiliated to Course of Technical Education and Vocational Training (CTEVT). The workers were provided with entrepreneurship training



along with basic tools and equipments to startup their planned business to become self-reliant. The project supported 41 brick workers with income generating activity (IGA) as per their need. In FY 21, the prioect successfully linked 189 workes to formal savings institutions and made them aware on savings habit which inturn have maximized to benefit child well-being. In 3 years, total 373 workers were linked to saving institutions. Also, 156 families in Sarlahi district were linked to Government Health Insurance program to ensure their phsyical well-being. Altogether, 462 workers received direct health services within the 3 years. The project also conducted monitoring of the outcomes and found families who had been insured were actively seeking health care support and have been renewing their health insurance card each year.









b. Self Education and Employment Project

Project Goal: Empower and strengthen the capacity of vulnerable and marginalized women through literacy and social entrepreneurship initiatives.

CDS in support of FoNAI, & Rotary Clubs of Australia and Rotary Club of Dillibazar-Ktm are jointly implementing the Self Employment Education Program (SEEP) Panchkhal Municipality, in Kavre, Godhagodhi Municipality, and Bhajani Municipality of Kailali districts of Nepal. Mainly on 7 wards, the program is focused (i.e., wards 3, 7, 9 & 12 of Panchkhal Municipality, Kavre; ward no. 2, 8 & 9 of Godhaghodi Municipality, and ward 4 of Bhajani Municipality, Kailali). The project has been implemented in close coordination with Panchkhal Municipality, Bhajani Municipality, & Godhaghodi Municipality, youth club, mother groups, educational section, health post, women and children's section, and communities of the aforementioned wards of respective local level.

The main objective of the program was to lead Non-Formal Education programs to encourage income generating activities

for the women and increase their access. to economic initiatives. The program also taught literacy and numeracy to 149 women, and increased awareness among the SEEP group of women's rights, legal issues, reproductive health, basic health and sanitation, positive parenting, rights of children and education surrounding, HIV & AIDS. Savings workshop were also run, to encourage small scale saving in the community. The women are the immediate beneficiaries of the SEEP program, however, the women are the primary care takers of the family. SEEP aims to empower women, and in doing so, increase the quality of life and rights of their children.


Objectives of the program:

- To literate the illiterate women
- To make women aware about the importance of savings credit mobilization
- To empower women on alternative and viable livelihood options through nonformal education
- To motivate women to do their own small business to incline to selfempowerment
- To improve in economic condition/ livelihood

- To make women capable of increasing their income to support their family economically
- To make women self-dependent and increase their self confidence
- To improve the health and education of children
- To reduce Child labour and
- To make children capable for ensuring child rights

SEEP Program Approaches and Process:

This program includes interventions like literacy classes and business education classes for the first 6 months and the implementation of interested businesses within the next 6 months, which in turn,



could support the education and health of children. The group was educated in literacy through classroom business education sessions, saving group formation among the participants, providing funds to the group as seed money to start smallscale businesses, and connecting them with the bank and local government. CDS will be in charge of continuous monitoring for the proper implementation of these interventions, as well as ensuring that the facilities are being utilized to the greatest extent possible by the target groups. Despite of the COVID -19 pandemic, major events were conducted, but some events could not be completed even during the long-term project period.

Major Achievements:

- Women groups have been getting support for soap making training, seed money, and materials/equipment from respective local government.
- 219 participants were able to read and write in simple Nepali words, English letters and numbers, add and subtract in mathematics after participating in daily literacy class.
- Local government are providing support and conducting regular monitoring.

- Municipality office, community people, parents and stakeholders are playing supportive role towards SEEP to acquire more fruitful results.
- Business plan has been prepared in each group and small-scale business has been started ie. grocery items, vegetable farming, poultry/goat farming, vegetable seeds and soap making
- Change in the behaviour of women in groups-led them to saving money, now which are inclined to shift to income generating intervention, which is a basic road map for the women for conducting livelihood activities in upcoming days.
- Each group opened the bank account and started saving. 10 groups are saving monthly in their respective saving group with 219 members.

Major activities conducted

Community Orientation Program and Baseline

A Community Orientation Program (COP) and baseline survey were conducted in the initial phase of the program. Participants were well informed about CDS and the importance of SEEP, the target group and

the expectations from the organization. Community members have shown their commitment to supporting this program. A baseline survey has been completed of the participants for the generation of data.

Literacy Class and Business Education Workshop

A total of 219 women are participating in the literacy and numeracy classes and Business Education workshop in 10 areas of Kavre & Kailali districts. Two books, 'Nirantar Shikshaa' (level one and level two) are used in the SEEP class for literacy and numeracy learning, which are prescribed by the Government of Nepal for Non-Formal Education (NFE). In daily class, participants learned numbers, simple mathematics, writing, and reading. Focus group discussions, multi-level and multigrade teaching methods are used in the

class for literacy and numeracy learning. Group Discussion Manual is basically focused on credit mobilization, feasibility studies of small businesses, rules and regulations, SWOT Analysis, market management, linkage and coordination, utilization of local resources, maintenance of financial records, etc. Participants were found to be very interested in reading, writing, and participating in the class. Now they can read and write simple paragraphs and letters. Other additional subjects for learning in the classes are as follows:







- Interaction about first aid and health precaution
- Teaching English letter and words
- Family planning and advantage of small family
- Preparation of group registration in local organization
- Discussion on special care during pregnancy period
- Practice on simple mathematical problem
- expenditure management with techniques on how to increase income source in the same community
- Discussion about business and profit/loss
- Role division on business and make plan for upcoming business

Interaction in different subjects

Parents and Group Management Committee (GMC) meetings have been held and conducted on various topics regarding positive parenting, importance of education, children's care, child rights and child labour, their roles in the family, and how to bring positive change in their lives through this program. Participants shared their views during the program and practiced it regularly in their homes. They stated that the SEEP classes can play a vital role in changing their lives and they have a major role to play in reducing the number of children working in the hazardous labour sector. Interactive sessions encouraged participants to bring the difference.

Experimental Business Fund Distribution

Per group, Rs. 35,000/- has been transferred to the bank account of 10 groups. Bank deposit slip is handed over as seed money for the small businesses of the groups this year. CDS personnel have participated in discussions about women's empowerment, literacy, business, and obtaining local government assistance. SEEP participants are grateful to CDS, FONAI, and Rotary clubs of Australia and Rotary club of Dillibazar for their livelihood support to ensure the safe future of their children.





In one of the grant support to graduated SEEP group, Deputy Mayor of Panchkhal Municipality remarks-

"SEEP projects have supported to enhance women's confident level to make decision on day to day matters in thier life. Member of the women group fell proud and started to live a life with dignity. We have to be independent and smart to get information from the NGOs and the municipality. Women group also become aware to take action against domestic violence against women at household level, caste discrimination & child abuse by reporting timely to respective authority such as police station"

Regular Supervision and Monitoring

Regular supervision and monitoring of the SEEP class was done by the CDS board, executive director, program manager, finance manager, program officer, and program supervisor. They observed and interacted with female participants to find out the gaps during the implementation of the intervention and gave a way forward to fill the gaps. The facilitators have been helped for the quality improvement of service delivery through the feedback. The Deputy Mayor of Panchkhal Municipality has been regularly



monitoring and providing support from the local government for the empowerment of women.

Coordination

Regular coordination has been done with Panchkhal & Ghodaghodi Municipality officials, Mother's group, Youth Club, Health Post, Police Post, Women & Children branch, Education branch, and community people at local level for smooth interventions of SEEP. All stakeholders have been equally supportive with regard to the program. Regular coordination and support from the agriculture section, health post, and bank for the group will be beneficial for the sustainability of the group. Groups can open bank accounts and conduct regular transactions, saving and starting affiliation with the agriculture

section of their local government. They are recognized as a functional farmer's group in the community. These groups will get support for modern agriculture tools, equipment, and seeds, access to use other benefits like loans, seeds, money, material, technical training, as well as some amount of money, support for linkage with other partners, and networking support to promote their business.



5. CHILD CENTERED DISASTER RISK REDUCTION THEME

To increase the resilient capacity of communities and local government officials to manage disaster shocks and stresses by taking ownership of their Local Disaster Risk Management Plans.

a) Nepal Disaster Risk ReductionProject (NDRR)

Project Goal: Increase the resilient capacity of communities and local government official to better manage disaster shocks and stresses by taking ownership of their own Local Disaster Risk Management Plans.

Within this year, CDS is implementing Nepal Disaster Risk Reduction (NDRR) project partnered with World Vision International Nepal. NDRR project mainly focused on preparation of Local Disaster Climate and Resilient Plan (LDCRP) as well as Disaster Preparedness and Response Plan (DPRP) in Chandragiri Municipality.

Drinking Water Supply and Retaining Wall Construction

With the aim of minimizing and safeguarding the risks of disaster. CDS implemented NDRR project in collaboration Chandragiri Municipality to work on its higher vulnerable zones. In the preliminary phase CDS conducted training program of Vulnerable, Hazard and Capacity Building selecting 3 wards of the municipality assisting 9 trainees from each ward representing various social background as to prepare action plan. The prepared action plan was presented and discussed at municipality office in the presence of Mayor, Deputy Mayor, and officials of Municipal Disaster Management Committee, Consultant, Staff members and key concern stakeholders. The discussion session forwarded two projects: Harddhungaa drinking water pipe laying in Masine, Chandragiri-2, with length of 935m distance and drinking water pipe of 63mm/6kg/cm2 were managed for the drinking water supply to the 200

family. Umamaheshower Retaining wall construction in Dauradipo, Chandragiri-5 with the total outcome of 32m3 including M15 PCC and 38mm Cement Concrete. The difficult geographical terrain land hurdles more as the site slope runs down and constructed the retaining wall to protect the land slide.

As per demand for Child friendly drinking water at school, It was constructed at Shree Bidhya Mandir and Kankali Secondary School, Naikap, Kathmandu under the mitigation work. About 400 students have easy access to drinking water in both school. The school management Committee are very happy to have constructed taps for Students. Finally, It has been handed over to School Management Committee.

b) COVID-19 Response and Relief Project (COVER-II)

The project supported children and families in 8 brick industries prioritizing on health & hygiene, food security and protection interventions in response to the second wave of COVID-19 pandemic. Three Hundred Fifty-two HHs constituting of 1082 families were supported with food ration to meet their immediate nutritional

requirements. The food ration quantity was as per the relief distribution guideline of the Government of Nepal. Additionally, the project also supported 175 children in four-child care home in Chandragiri Municipality with food packages to meet their nutritional requirement. And 288 self-learning materials (Grade 1 to 5) for brick workers' children were supported focussing on the education of children during COVID 19 pandemic. Local government of project sites were supported with health equipment such as oxygen cylinder, oximeter, thermal temperature gun and PPE sets for operation of the isolation ccenter established by them. Public Service Announcement (PSA) regarding precautionary measures on COVID-19 was declared in all brick industries through loudspeakers. Similarly, professional counsellors provided psychosocial counseling via telephonic calls to children and families working in the brick industries.











Other Initiatives of CDS

Contribution for campaign (CFLG, CHILD LABOUR FREE)

Child Development Society has been working to ensure child rights from its' establishment. This year CDS contributing to local government for the campaign of Child Friendly Local Governance and Child Labour Free. With financial support from WVIN, CDS has been supporting to make Child Friendly ward-7 of Kirtipur and Child Labour Free ward-14 of Chandragiri Municipality Kathmandu. This campaign is in semi-final stage for the declaration.

Awarded as a best PNGO-2021

World Vision International (WVI) Nepal has awarded CDS a 'Partner NGO Performance Excellence Award 2021' in an event organized by WVIN in Lalitpur on 29 September 2021. This time our hard work pays off and succeeded to achieve WVI Nepal Partner NGO Performance Excellence Award 2021. Kudos to all the hardworking CDS family!

'Partner NGO Performance Excellence Award is an initiative by World Vision International Nepal to recognize its partner NGOs for their outstanding performance and achievements in their respective fields.

Social Audit:

September, On 25th 2021 Child Development Society organized a social audit program at Sanchayakosh Bhawan Lalitpur. The programme was hosted by Sriiana Dahal and Prakash Sunuwar, in the presence of our respected figures- Mr. Subhas Gautam (CDS Chairman), Sarita Dahal (Deputy Mayor, District Coordination Kathmandu). Deputy Committee. Mayor from Suryabinayak, Chandragiri, Gokarnaeshwor Municipalities representative District and from Administration Office-Ktm, Social Welfare Council, Ward Chairman are participated. Other I/NGO, CBOs, major stakeholders and beneficiaries from project area of Ktmvalley and the participants of vocational skill training are actively participated.

Mr. Pradip K. Shrestha (CDS Program Manager) presented annual report of FY 2077/078 of CDS with having interactive discussion on different related issues and to make upcoming activities more effective and sustainable. Stakeholders raised various issues relating to organization,



its system and programs on the floor after facilitating the program. The issues/ questions raised in floor were addressed by respective office bearers of CDS. Respected representative figures set forth their remarks as an added value to the social audit program, with the remarks of both appreciation and encouragements. Beneficiaries expressed their vote of thanks and their perspective on how the project has impacted their lives, family and community.

Project Advisory Committee Meeting:

On 17th September 2021, District Project Advisory Committee (DPAC) meeting was conducted at District Co-ordination Committee, Babarmahal, Kathmandu. The major objective of this meeting was to share the overall program achievement and discuss on areas of improvement of

the projects functioning at Kathmandu district.

District Coordination Committee (DCC) Officer Mr. Rajendra Bahadur Aryal chaired the meeting. Chief guest Mr. Shiva Sundar Raj Baidya and Vice Chair person, District Co-ordination committee Mrs. Sarita Dahal and Deputy Mayor of Chandragiri and Kirtipur, including Social Development section head also participated in the program.

On 10th September 2021, Municipal Project Advisory Committee (MPAC) meeting was conducted at Lalitpur Metropolitan City office. Deputy Mayor Mrs. Geeta Satyal chaired the meeting. In similar manner, Social Development Committee Coordinator, Education, Health, and Social Welfare Division Section Head also participated in the program.

Capacity Building of Staff:

In this year CDS managed different types of training to build capacity of staff. CDS itself and coordination with other organization staff get Sponsorship Approach, Child Protection, Child Friendly Local Governance, Grievance Handling Mechanism, case management and other emerging issues related to children. These

training and workshop helped CDS staff for their professional work with the getting learning in emerging issues and exposure visits.


Research Report Disseminate:

Ministry, local government, like minded organization, CBS & media that reflects the current status of children working in carpet and garment industry which seemed to be in decremented in compare to 1990. The findings will be the instrumental tool for others in the sector of child labour.






